**RE: The attempted “Unlawful Detainer” enforcement action associated with the property**

Sheriff Sanchez:

Given your commitment to community trust and partnerships, focus on transparency and accountability, and a leadership of empathy and compassion, and your insights into the damaging effects that lack of support systems and resources have on people and communities, it is important that you pay attention to this letter and notice.

This Notice is issued purely as a lawful and necessary act of self-protection and shall not be construed as consent to, participation in, or recognition of any jurisdiction by any forum whatsoever or any presumed “case” constructed against the undersigned. It is issued entirely outside and beyond any and all such frameworks.

This matter is the result of **a criminal enforcement attempt by a forum and party who are both fatally disqualified on multiple grounds** from even communicating with the undersigned, let alone invoking your office for an “eviction”, and have been independently noticed and warned. As such any “order” you hold or may hold is fraudulent and culpable on its face. A Public Notice archive of relevant Notices and communications to the initiating party, months prior to their attempted “Unlawful Detainer” action, is here: <https://www.metanoia-inc.com/public-notices>. This archive evidences the absence of standing, and the illegitimacy of any invocation of any forum for “redress.”

Therefore, absolutely *any* act by you, your office, and/or any member of your staff now, to enter, touch, or interfere with the undersigned, and their offices, belongings, documents and contents or any and all of their other effects, at the property at [REDACTED], will be culpable, together with both of the above, and all involved.


You, your office, and members of your staff will become, ***jointly and severally***, both ***professionally and personally***, liable for: abuse of process, for violation of your oath, for trespass, and **the infliction of grievous and irreversible, unlawful, illegal, and criminal harm**, including *deliberate disruption, destruction, and devastation of the life, work, livelihood, and business operations of the undersigned, in both his personal and professional capacities.*

It would be prudent of you to halt all ongoing and/or contemplated action, and confirm matters before risking acting indiscriminately on fraudulent “orders” and being held culpable. This warning is issued in advance, precisely **because no jurisdiction has attached nor can it ever attach**, and because the undersigned **must preempt any misapplication of your authority to trespass upon life, liberty, happiness, property, or estate.**

**It is your duty** — and that of any who act under your seal — **to confirm directly with the undersigned**, the lawfulness and legitimacy of any matter before attempting enforcement based on contested and disqualified filings and a forum acting without any basis whatsoever. Failure to do so will serve as unmistakable evidence of willful blindness and conscious collusion in criminal conduct.

Additionally, any and all actions undertaken by the undersigned (in his personal and/or professional capacity) and his company after your receipt of this Notice — to remedy or respond to actions by your office, by you personally, or by any member of your staff — shall be billable at our then prevailing professional rates to all three, jointly and severally: the Office of the Sheriff, you in your personal capacity, and each staff member involved in their personal capacities, jointly and severally. These charges shall be non-contestable, as they would be the direct result of conduct you had the clear opportunity and duty to prevent.
